WHEREAS the Council of The Corporation of the Town of Kingsville deems it expedient to amend By-law 48-2008, being a By-law which appointed certain Members and individuals to certain Authorities, Boards and Committees for the period from December 1, 2006 to November 30, 2010, for the purpose of adding lay appointees to the Splash Park Advisory Committee.


